
COVID-19 PROCEDURES - UPDATE 08JUN20 Last updated on: 08 Jun 2020

For extraordinary times, extraordinary solutions.

For passengers with original travel date up to the 30th of September and tickets issued until the 15th of May 2020, who wish to keep their tickets and rebook later, TAP will offer a discount of € 25 or € 100, depending on the route, for new dates/routes.

From the 8th of June 2020: TAP will offer a 20% bonus to passengers with cancelled flights (UN status) that have their original travel date up to the 31st of August 2020 and choose a refund voucher to use on a new ticket.

How to price the new ticket with the offer ⁽²⁾ Regarding new TST two situations must be observed : 1. If the amount of the difference to be paid is equal or less than the discount to be applied, apply NOADC (and no credits remain) 2. If the amount of the difference to be paid is higher than the discount, insert the amount to be collected in total amount field. Insert old form of payment shown on the original ticket and insert a new form of payment with the additional to be collected from the passenger. Validity: to be used as payment up to 2 years from the date of issue; 1 year for vouchers issued from th 8th of June.

Non refundable

For travel or services on flights operated by TAP

For full of partial use. The remainder can be used on another journey, within the validity period.

Transferable, with authorization of the holder

Vouchers used by an agency or passenger on a TAP direct channel (flytap.com or Contact Center), originating from a ticket issued by a travel agency, will be considered agency revenue for the purpose of calculating incentives.

VOUCHERS ISSUED AGAINST TICKETS WITH ORIGINAL TRAVEL UNTIL JUNE 30(3)

20% bonus - applicable to tickets where no flight coupon has yet been used.

Additional value is calculated based on the total value of the ticket. For example, for an ticket value of 100EUR the voucher will be issued in the total amount of 120EUR Valid for vouchers requested from April 9

(3) From 8th of June: We extended the bonus to tickets with a travel date until August 31, in case of flight cancellation (UN status)
