<u>RE-BOOKING/CANCELLATION PROCEDURES FOR PASSENGERS TICKETED ON UL DOCUMENTS</u> <u>SEAT ONLY FARES.</u>

Below policy supersedes all policy guidelines issued to date pertaining to Covid-19.

The following options are available to all passengers who have purchased their tickets (Fully unutilized/Partially utilized (including group) on UL document on or before 31 Jul 2020 for travel commencing between 26 Jan to 30 Sep 2020, who now wish to alter their travel plans due to flight cancelations/flight service restrictions/specific country regulations and other related issues due to COVID-19.

For Flights Operating as scheduled -

a) Free Change

- \cdot Unlimited date changes permitted without change fee.
- · Applicable fare difference shall apply.
- · Change of route/flight number is permitted. Applicable fare differences will apply.
- Rebooking/re-issuance must be completed prior to 30 Sept 2020.
- · If re-booked in same RBD, fare difference and penalty shall not apply.
- \cdot If same RBD is not available raise to next RBD /fare. Fare difference shall apply. Penalty shall not apply.
- \cdot This is applicable for itineraries with codeshare/interline sectors.
- \cdot Any change in taxes shall be applicable.
- · Ticket endorsement to be "Covid19 AUTH"

b) Refund

· Option 1 - Travel Voucher

 \cdot Ticket may be exchanged for a travel voucher valid up to one year from the date of issuance of the voucher for the total cost of the ticket.

• This voucher can be used to avail multiple tickets from UL within its validity/Value.

 \cdot Any residual value of the travel voucher upon expiry may be extended for a further one-year period.

· Travel voucher may be transferred with indemnity.

· This voucher is non-refundable.

· Option 2 – Refund

· Request for refund, applicable fare rules shall apply

Note: No-show fee shall be waived off for all re-issuances for travel up to 31 May 2020

FOR CANCELLED FLIGHTS ONLY DUE TO COVID 19 – 15 MARCH to 31 JUL 2020

Option 1 - Re-issue

• Passengers holding **UL Seat Only tickets issued in UK from 26 Jan to 31 Jul 2020 to travel ex LON to CMB & points beyond** during 26Jan'2020 to 30Sep'2020, who were impacted by flight cancellations/travel bans/travel advisories/quarantine situations due to COVID-19 pandemic.

• Such passengers holding tickets issued up to 31 Jul 2020, to travel during 26Jan20 to 30 Sep'20, who now want to change their travel plans can get their tickets re-issued to travel during period 01 Aug 20 to 30Jun'2021, at the same fare in the same cabin in any RBD, subject to conditions given below.

Note –

- Change fees will not apply.
- New travel date to be finalized and tickets to be re-issued on or before 30Sep'2020.
- All Seat Only fare conditions must be met.

- Same routing as per original ticket is to be maintained. In the event of routing change, the applicable fare difference is to apply.

- If new travel date ex LON falls on to a Day 5/6, weekend surcharge to be waived off.

- If new travel date from/to LON falls on to a peak of peak period in Summer 20 (i.e. LONCMB during 17Jul-02Aug'20 and/or CMBLON during 21Aug-06Sep20), the applicable peak of peak surcharge is to be waived off.

- Endorsement - SO/CV19/REISSUE

-In case the booked flight has not been cancelled/affected, but the passenger wishes to alter the travel date, the ticket may be re-issued as per fare rules applicable for fare on ticket (i.e. change fee and/or a difference in fare may apply).

· Option 2 - Travel Voucher

 \cdot Ticket may be exchanged for a travel voucher valid up to one year from the date of issuance of the voucher for the total cost of the ticket.

• This voucher can be used to avail multiple tickets from UL within its validity/value.

 \cdot Any residual value of the travel voucher upon expiry may be extended for a further one-year period.

· Travel voucher may be transferred with indemnity.

· This voucher is non-refundable.

· Option - Refund

 \cdot Request for refund, penalty waived for cancelled flights from 15 March to 31 Jul 2020. Note: Tickets related to this circular shall be finalized (refund/changes) by 30 Sep 2020 by proceeding with necessary changes/refunds
