## Your guide to understand if a Lufthansa Group airlines' flight irregularities or goodwill policy may apply to a ticket

### Standard procedure in case of cancelled flights - irrespective of any (additional) goodwill policy:

- In general, you can rebook/reissue on original origin and destination (O&D) on involuntary basis.
- Following adaptions of the standard flight irregularity policy currently apply :
  - If the original booking class is not available for the new travel dates, you may rebook currently also in the lowest available booking class within the same cabin/compartment (original transportation class) outside the 3-day period (three days before/after the original flight). This is applicable only to Lufthansa Group flight numbers (OS/LH/LX/WK/SN/EW/4U/EN).
  - Until further notice, **rebookings/reissues** can also be made **outside the 14-day period.** Please note that it is still necessary to delete active and inactive flight segments first from the PNR within the 14-day period.
- Further detailed rules as per flight irregularity policy.

#### Please note:

In case of cancelled flights you may choose if you want to rebook/reissue

- on involuntary basis (original O&D, no additional collection, no discount, no bonus) or,
- on the basis of a goodwill policy (repricing on any O&D) within the timeframes of the respective goodwill policy and a discount/bonus where
  applicable

## The goodwill policies apply to cancelled and non-cancelled flights

Both goodwill policies (TWP 2011/TWP 2013) are applicable to any OS/LH/LX/SN/EN ticket (257/220/724/082/101) with a booked OS/LH/LX/WK/SN/EW/4U/EN flight number and a travel date on/before 30 April 2021



The validity of the existing goodwill rule TWP 2011 was extended until 15 May 2020 (date of ticket issuance). With immediate effect, the previously published TWP 2012 is no longer valid.

The following rules apply to all rebookings/reissues done on the basis of these goodwill policies and to the adapted flight irregularities policy

### Please note:

- Change of the passenger ("Name Change") is not permitted
- PNR clean-up mandatory: Always cancel flights which are not needed anymore and remove segments with an inactive status code like UN as soon as possible.
- Endorsement Box:
  - For reissues based on the involuntary rules: SKCHG/affected flight number/date
  - For reissues based on any goodwill policy (TWP): TWP 2011 or TWP 2013
- Fare construction:
  - For reissues based on the involuntary rules, start the fare construction with S- (SKCHG)
  - For reissues based on any goodwill policy, use standard fare construction

- For customers who do not wish to take advantage of any of these flexible rebooking options, you can still submit tickets for refund either per original fare rule or on involuntary basis in case of cancelled flights. Due to the current situation there may be delays in processing refund requests.
- You can make all rebookings/reissues according to these goodwill rules (TWP 2011/TWP 2013) and according to the flight irregularities policy (cancelled flights) yourself; **an approval** from your Lufthansa Group Agency Support **is not required.**
