When issuing a voucher in exchange of tickets issued before July 9, 2020, it is necessary to apply the rules effective on the day when the ticket was issued (Table 2).

When issuing a voucher in exchange for completely unused tickets reissued from July 9, 2020 inclusively, it is necessary to apply the new rules effective on the day of the reissue indicated in Table 1.

The issuance of a voucher in exchange for a ticket is proceeded in accordance with the current "Guidelines on handling traffic documents purchased with Travel Voucher".

In order to avoid conflicts with passengers, when issuing tickets please read the fare rules carefully and warn passengers about the conditions of voucher issuance.
