- 4. All cost associated with testing must be borne by passengers.
- 5. Any pax arrived without PCR test as mentioned above will be denied entry to BAH and pax will be deported back to their origin.
- 6. No PCR test will be permitted to be done at BSH hospital for passenger mentioned in # 5
