#### Travel Advisory on COVID-19 coronavirus outbreak

#### Dated 09<sup>th</sup> March 2022(Revision 0)

Prepared in accordance with IATA News daily updates and based on travel advisories that we are aware of published on Mar 09<sup>th</sup>, 2022.

You are advised to monitor and check official websites of World Health Organization, relevant authorities and local government agencies for the latest developments on COVID-19 coronavirus. Do adjust your travel plans based on the latest information provided.

AUSTRALIA - published 21.02.2022

1. Passengers must have a COVID-19 vaccination certificate showing that they were fully vaccinated at least 7 days before departure. Vaccines accepted are: AstraZeneca (Vaxzevria), AstraZeneca (Covishield), Covaxin, Janssen, Moderna (Spikevax), Nuvaxovid (Novavax), Pfizer-BioNTec (Comirnaty), Sinopharm (BIBP) (for passengers younger than 60 years only), Sinovac and Sputnik V. This does not apply to: - nationals and residents of Australia; - passengers with an approved travel exemption. More information can be found at https://covid19.homeaffairs.gov.au/coming-australia; - passengers younger than 12 years and 3 months at the time of departure; - passengers between 12 and 17 years traveling with a fully vaccinated parents/guardians. 2. Passengers entering or transiting through Australia must have: - a negative COVID-19 test taken at most 3 days before departure from the first embarkation point. Tests accepted are: LAMP, NAAT, PCR, RT-PCR and TMA; or - a negative COVID-19 rapid antigen test taken at most 24 hours before departure from the first embarkation point. More details can be found at https://tinyurl.com/y398dxv4 - This does not apply to: - passengers younger than 4 years; - passengers arriving from Kiribati, Myanmar, Niue, Samoa, Solomon Isl., Tokelau, Tonga, Tuvalu or Vanuatu; - passengers arriving from Belize, Cook Isl., Fiji, French Polynesia, Marshall Isl., Micronesia (Federated States), Nauru, New Caledonia, Palau, Papua New Guinea, Timor-Leste or Wallis and Futuna Isl. with a negative COVID-19 test taken at most 96 hours before departure from the first embarkation point. Tests accepted are: LAMP, NAAT, PCR, rapid antigen, RT-PCR and TMA; - passengers with a recovery certificate issued at most 30 days before departure from the first embarkation point. 5. Quarantine arrangements for airline crew are subject to respective state or territory requirements.

BAHRAIN - published 06.03.2022

- 1. The following passengers are allowed to enter:
- nationals of Bahrain, Kuwait, Oman, Saudi Arabia and United Arab Emirates;
- passengers with a residence permit issued by Bahrain;
- passengers with an e-visa obtained before departure;
- passengers who can obtain a visa on arrival;
- military personnel;
- passengers with:

- a COVID-19 vaccination certificate showing that they were fully vaccinated at least 14 days before arrival. The certificate must be issued in countries that are eligible for visa on arrival; or

- a COVID-19 vaccination certificate showing that they were fully vaccinated at least 14 days before arrival. The certificate must have a QR code; or

- a COVID-19 vaccination certificate showing that they were fully vaccinated at least 14 days before arrival.
 The certificate must be issued in Australia, Austria, Belgium, Bulgaria, Canada, Croatia, Cyprus, Czechia,
 Denmark, Estonia, Finland, France, Germany, Greece, Hungary, Ireland (Rep.), Israel, Italy, Japan, Jordan,
 Korea (Rep.), Kuwait, Latvia, Lithuania, Luxembourg, Malta, Netherlands, New Zealand, Oman, Saudi Arabia,
 Seychelles, Poland, Portugal, Romania, Singapore, Slovakia, Slovenia, Spain, Sweden, Switzerland, United
 Arab Emirates, United Kingdom or USA.

Vaccines accepted are: AstraZeneca (SK Bioscience), AstraZeneca (Vaxzevria), Covishield, Janssen, Moderna (Spikevax), Pfizer-BioNTech (Comirnaty), Sinopharm, Sinovac and Sputnik V.

2. Visa on arrival facility restarted.

- This does not apply to passengers with a residence permit issued by Kuwait, Oman, Saudi Arabia or United Arab Emirates, if arriving from a country other than Kuwait, Oman, Saudi Arabia and United Arab Emirates.

BANGLADESH - published 09.03.2022

 Passengers must have a negative COVID-19 RT-PCR test taken at most 48 hours before departure from the first embarkation point.

- This does not apply to passengers younger than 12 years.

-This does not apply to fully vaccinated passengers who have taken approved vaccinations

2. Passengers must complete a "Health Declaration Form" and present it upon arrival. The form can be found

- 3. Passengers are subject to medical screening.

4. Passengers who in the past 14 days have been in or transited through Botswana, Eswatini, Ghana, Lesotho, Namibia, South Africa and Zimbabwe must have a hotel booking for 14 days.

- 5. Passengers are subject to quarantine for up to 14 days. Details can be found

- 6. Suspension of visa on arrival facilities.
- This does not apply to:
- passengers of Bangladeshi origins, their spouses and children;
- passengers with a diplomatic or official passport;
- passengers traveling on business.

### CANADA - published 02.03.2022

1. Passengers and airline crew must have a COVID-19 vaccination certificate uploaded in ArriveCAN showing that they were fully vaccinated at least 15 days (day of vaccination + 14 days) before arrival. The certificate must be in English, French or accompanied by a certified English or French translation. Vaccines accepted are: AstraZeneca (Covishield), AstraZeneca (SK Bioscience), AstraZeneca (Vaxzevria), Covaxin, Covovax, Janssen,

Moderna (Spikevax), Nuvaxovid (Novavax), Pfizer-BioNTech (Comirnaty), Sinopharm or Sinovac. A combination of vaccines is accepted.

- This does not apply to:

- nationals of Canada;

- permanent residents of Canada;

- persons registered under Canada's Indian Act with the Certificate of Indian Status (CIS) or the Secure Certificate of Indian Status (SCIS);

- passengers with an authorization from the Public Health Agency of Canada (PHAC) for compassionate entry;

- passengers with a Canadian Refugee Travel Document or a Single Journey Document for Resettlement to Canada;

- passengers younger than 12 years traveling with their vaccinated parents/guardians;

- passengers with an application for permanent residence. They must have a written notice issued under the Immigration and Refugee Protection Act.

2. Passengers must have:

- a negative molecular COVID-19 test taken outside of Canada at most 72 hours before departure of the last direct flight to Canada. Tests accepted are: CRISPR, Ct, detection of the E gene, detection of the N gene, detection of Orf1a/b, detection of the RdRp gene, detection of the S gene, ddPCR, isothermal amplification, LamPORE, NAAT, NAT, NGS, PCR, qPCR, RNA, RT-LAMP, RT-PCR, sequencing and WGS; or

- a negative COVID-19 antigen test taken at most one day before departure of the last direct flight to Canada. More details can be found at <u>https://tinyurl.com/uuf5nntc</u>

- This does not apply to:

- passengers younger than 5 years;

- passengers with a positive molecular COVID-19 test taken at least 10 days and at most 180 days before departure of the last direct flight to Canada. Tests accepted are: CRISPR, Ct, detection of the E gene, detection of the N gene, detection of Orf1a/b, detection of the RdRp gene, detection of the S gene, ddPCR, isothermal amplification, LamPORE, NAAT, NAT, NGS, PCR, qPCR, RNA, RT-LAMP, RT-PCR, sequencing and WGS;

3. Passengers and airline crew must submit their information electronically, at most 72 hours before arrival, through the ArriveCAN app or the website <a href="https://www.canada.ca/en/public-">https://www.canada.ca/en/public-</a>

<u>health/services/diseases/coronavirus-disease-covid-19/arrivecan.html</u>. Passengers must present an ArriveCAN receipt before boarding.

4. Passenger could be subject to COVID-19 molecular test upon arrival. Details can be found

- This does not apply to:

- passengers younger than 12 years traveling with their fully vaccinated parents/guardians;

- passengers with a COVID-19 vaccination certificate showing that they were fully vaccinated at least 15 days (day of vaccination + 14 days) before arrival. The certificate must be in English or French or be accompanied by a certified translation to English or French.

- Vaccines accepted are: AstraZeneca (Covishield), AstraZeneca (SK Bioscience), AstraZeneca (Vaxzevria), Covaxin, Covovax, Janssen, Moderna (Spikevax), Nuvaxovid (Novavax), Pfizer-BioNTech (Comirnaty), Sinopharm or Sinovac. **THE MAINLAND OF CHINA** - published 28.01.2022

1. Entry by foreign nationals holding a visa is suspended.

- This does not apply to:

- foreign nationals with a visa issued after 28 March 2020 with the place of issue outside the Mainland of China. They must not arrive from Bangladesh, Belgium, France, India, Italy, Philippines, Russian Fed. and United Kingdom;

- foreign nationals with a diplomatic, service, courtesy or C visa;

- foreign nationals with a visa issued after 3 November 2020;

- passengers with an invitation letter issued by the Beijing Organising Committee for the 2022 Olympic and Paralympic Winter Games.

2. Entry by foreign nationals with a residence permit is suspended.

- This does not apply to:

- foreign nationals with a permanent residence permit;

foreign nationals with a residence permit with the purpose 'work', 'personal matters' or 'reunion'. They must not arrive from Bangladesh, Belgium, France, India, Italy, Philippines, Russian Fed. and United Kingdom.
Entry by foreign nationals with an APEC Business Travel Card is suspended.

4. Port visas, 24/72/144-hour visa-free transit policy, Hainan 30-day visa-free policy, 15-day visa-free policy specified for foreign cruise-group-tour through Shanghai Port, Guangdong 144-hour visa-free policy specified for foreign tour groups from Hong Kong or Macao SAR, and Guangxi 15-day visa-free policy specified for foreign tour groups of ASEAN countries are suspended.

5. Foreign nationals coming to the mainland of China for necessary economic, trade, scientific or technological activities or out of emergency humanitarian needs may apply for visas at Chinese embassies or consulates.

6. Passengers are subject to medical screening and quarantine for 14 days at the first point of entry.7. Airline crew of foreign airlines:

- are not required to undergo nucleic acid test if they have a short stay after landing then depart immediately, and do not leave apron during the transition; OR

- shall receive nucleic acid test in the first port of entry if they need to enter the country to rest or continue to operate domestic routes. The test results will be confirmed by the local government in accordance with the requirements of epidemic prevention management. Only if the test results are negative, crews can continue the operations; OR

- are allowed to return to their home country for isolation treatment when agreed by the local joint control mechanism, if they are symptomatic, in close contact with infected persons or tested positive. Airlines and crews shall make all commitments to bear their responsibilities and also carry out strict protections.
8. Passengers must complete an "Exit/Entry Health Declaration Form" and present a QR code before departure. The form can be obtained at <a href="http://health.customsapp.com/">http://health.customsapp.com/</a>.

9. Nationals of China (People's Rep.) must have a green QR code with an 'HS' mark. The code can be obtained from the WeChat App 'Fang Yi Jian Kang Ma Guo Ji Ban' by uploading a negative Coronavirus (COVID-19) nucleic acid test result issued at most 2 days before departure and a negative IgM antibody test result issued at most 2 days before departure. A positive IgM antibody test result could be accepted with a COVID-19 vaccination certificate. More details can be found at the website of the respective Chinese embassy. Passengers not arriving directly in China (People's Rep.) must repeat both tests in the transit countries and obtain a new green QR code with an 'HS' mark in each transit country.

- This does not apply to:

- nationals of China (People's Rep.) arriving from Chinese Taipei, Hong Kong SAR, China, Macao SAR, China, United Arab Emirates or USA;

- passengers with an invitation letter issued by the Beijing Organising Committee for the 2022 Olympic and Paralympic Winter Games;

10. Passengers must have a green QR code with an 'HDC' mark. The code can be obtained

Passengers not arriving directly in China (People's Rep.) must repeat both tests in the transit countries and obtain a new green QR code with an 'HDC' mark in each transit country.

The code can be obtained from the WeChat App 'Fang Yi Jian Kang Ma Guo Ji Ban' by uploading a negative Coronavirus (COVID-19) nucleic acid test result issued at most 2 days before departure and a negative IgM antibody test result issued at most 2 days before departure. A positive IgM antibody test result could be accepted with a COVID-19 vaccination certificate. Passengers must also have a negative COVID-19 nucleic acid test taken 7 days before departure, and complete a personal health monitoring form. More details can be found at

12. Passengers arriving directly from the USA must have a green QR code with an 'HDC' mark. The code can be obtained at <u>https://hrhk.cs.mfa.gov.cn/H5/</u> with a negative Coronavirus (COVID-19) nucleic acid test result issued at most 2 days before departure and a negative IgM antibody test result issued at most 2 days before departure. A positive IgM antibody test result could be accepted with a COVID-19 vaccination certificate. 14. Passengers arriving directly from Canada must have a green QR code with an 'HDC' mark. 15. Nationals of China (People's Rep.) arriving directly from United Arab Emirates must have a green QR code with an 'HS' mark. The code can be obtained from the WeChat App 'Fang Yi Jian Kang Ma Guo Ji Ban' by uploading:

- a negative Coronavirus (COVID-19) nucleic acid test result issued 14 days before departure and a negative IgM antibody test result issued 14 days before departure; and

- a negative Coronavirus (COVID-19) nucleic acid test result issued at most 2 days before departure and a negative IgM antibody test result issued at most 2 days before departure. - This does not apply to:

- passengers with an invitation letter issued by the Beijing Organising Committee for the 2022 Olympic and Paralympic Winter Games;

16. Passengers arriving directly from United Arab Emirates must have a green QR code with an 'HDC' mark. The code can be obtained at <u>https://hrhk.cs.mfa.gov.cn/H5/</u> with:

- a negative Coronavirus (COVID-19) nucleic acid test result issued 14 days before departure and a negative IgM antibody test result issued 14 days before departure; and

- a negative Coronavirus (COVID-19) nucleic acid test result issued at most 2 days before departure and a negative IgM antibody test result issued at most 2 days before departure. Details can be found

- This does not apply to:
- nationals of China (People's Rep.);

- passengers with an invitation letter issued by the Beijing Organising Committee for the 2022 Olympic and Paralympic Winter Games;

- passengers with a Pre-Valid card (PVC) issued by the Beijing Organising Committee for the 2022 Olympic and Paralympic Winter Games.

17. Passengers arriving from Chinese Taipei must have a medical certificate with a negative Coronavirus (COVID-19) PCR test result issued at most 3 days before departure.

18. Passengers entering Beijing (PEK) from Hong Kong SAR, China must have a medical certificate with a negative Coronavirus (COVID-19) PCR test result issued at most 7 days before departure.

19. Passengers arriving from Macao SAR, China must have a medical certificate with a negative Coronavirus (COVID-19) PCR test result issued at most 7 days before departure.

The below items are regarding the 2022 Olympic and Paralympic Winter Games:

20. Passengers with an invitation letter issued by the Beijing Organising Committee for the 2022 Olympic and Paralympic Winter Games are allowed to enter with a visa.

21. Passengers with a Pre-Valid card (PVC) issued by the Beijing Organising Committee for the 2022 Olympic and Paralympic Winter Games are allowed to enter without a visa.

22. Passengers with an invitation letter issued by the Beijing Organizing Committee for the 2022 Olympic and Paralympic Winter Games must have a green QR code with an 'HS' mark (for Chinese nationals) or 'HDC' mark (for foreign nationals). The QR codes are valid for 72 hours after issuance, and they must be marked with 'Beijing Organising Committee for the 2022 Olympic and Paralympic Winter Games'. The QR code is considered valid at both origin airport and transit airport as long as it is within the validity at the time of boarding the plane to Beijing.

23. Passengers with a Pre-Valid card (PVC) issued by the Beijing Organising Committee for the 2022 Olympic and Paralympic Winter Games must have a green QR code with an 'HS' mark (for Chinese nationals) or 'HDC' mark (for foreign nationals). The QR codes are valid for 72 hours after issuance, and they must be marked with 'Beijing Organising Committee for the 2022 Olympic and Paralympic Winter Games'. The QR code is considered valid at both origin airport and transit airport as long as it is within the validity at the time of boarding the plane to Beijing.

24. The Olympic Identity and Accreditation Card (OIAC) and the Paralympic Identity and Accreditation Card (PIAC):

- are valid from 4 January 2022 until 13 April 2022; and

- are valid for multiple entries; and

- must be accompanied with a passport valid until at least 13 May 2022.

## EGYPT - published 01.02.2022

Passengers entering or transiting through Egypt must have:

- a printed negative COVID-19 PCR or rapid antigen test taken at most 72 hours before arrival. The test must be based on a nasal or oral swab. The test result must have a stamp of the issuing laboratory or a QR code. A COVID-19 RT-PCR test used to depart Egypt becomes invalid for re-entry in all cases; or

- a COVID-19 vaccination certificate showing that they were fully vaccinated with AstraZeneca (Vaxzevria), Janssen, Moderna (Spikevax), Pfizer-BioNTech (Comirnaty), Sinopharm, Sinovac or Sputnik V at least 14 days before departure. The certificate must be in Arabic, French or English and have a QR code; or

- a COVID-19 vaccination certificate approved and certified by the Egyptian Embassy in the country of departure showing that they were fully vaccinated with AstraZeneca (Vaxzevria), Janssen, Moderna (Spikevax), Pfizer-BioNTech (Comirnaty), Sinopharm, Sinovac or Sputnik V at least 14 days before departure.

- This does not apply to passengers younger than 12 years.

FRANCE - published 07.03.2022

1. Passengers must complete a Digital Passenger Locator Form found at https://app.euplf.eu/

- This does not apply to passengers who have started their journey in Russian Fed. or Ukraine.

2. Passengers must have:

- a negative COVID-19 PCR test taken at most 72 hours before departure from the first embarkation point; or

- a negative COVID-19 antigen taken at most 48 hours before departure from the first embarkation point; or - a COVID-19 vaccination certificate showing that:

- they were vaccinated with Janssen at least 28 days and at most 270 days before arrival; or

- they were fully vaccinated with AstraZeneca (SK Bioscience), AstraZeneca (Vaxzevria), Covishield, Fiocruz, Moderna (Spikevax), Nuvaxovid (Novavax), Pfizer-BioNTech (Comirnaty) or R-Covi at least 7 days and at most 270 days before arrival; or

- they were fully vaccinated with AstraZeneca (SK Bioscience), AstraZeneca (Vaxzevria), Covishield, Fiocruz, Janssen, Moderna (Spikevax), Nuvaxovid (Novavax), Pfizer-BioNTech (Comirnaty) or R-Covi and received a booster dose of Moderna (Spikevax) or Pfizer-BioNTech (Comirnaty); or

- they were fully vaccinated with Covaxin, Sinopharm or Sinovac and received a dose of Moderna (Spikevax) or Pfizer-BioNTech (Comirnaty) at least 7 days before arrival;

o Valid for nine (9) months from fourteen (14) days after 2nd dose or booster dose vaccination of <u>Pfizer</u>, <u>Moderna</u>, <u>Astra Zenica COVID-19 vaccines</u>.

o Valid for nine (9) months from 2 weeks after the 1st dose of Jansen & Jansen COVID-19 vaccine; or valid for nine (9) months from seven (7) days of receiving the booster dose of Jansen & Jansen COVID-19 vaccine. o Valid for six (6) months from fourteen (14) days after the 2nd dose or booster dose of <u>conditionally approved</u> <u>COVID-19 vaccines</u>, where a *positive* Serology on Antibody Test lab result is required and is valid for 30 days from testing; If the traveler is unable to take a Serology Antibody test in the country of origin or if the Antibody test result appear negative, the traveler must undergo relevant quarantine for 5 days; Those who received booster dose using MOPH approved vaccines immune status is extended to nine (9) months from seven (7) days after the booster dose and Serology Antibody test is no longer required.

• **Recovered:** Anyone who had a medically confirmed COVID-19 infection acquired either locally or overseas is considered to have immune status valid for nine (9) months from the date of the infection. There should be an official and verifiable laboratory test result as evidence of the past infection.

• Unvaccinated / Non-immune: Anyone who does not meet any of the above criteria.

Travelers who are vaccinated outside Qatar are required to submit the original vaccine certificate and any other supporting documents –in Arabic or English language– as a proof that they have obtained the vaccine and should at least include the following information:

- o The name of the traveler must be identical to that on the passport.
- o Doses and dates of vaccine given (one dose for Jansen vaccine and two doses for other vaccines).
- o Type/name of vaccine.
- o The serial number of the vaccine batch and QR code (if available).

## General policy:

- 1. Based on COVID-19 epidemiology in different countries and their local health risk indicators, Qatar has developed specific health and safety measures for travelers coming to Qatar *Standard Health Measures and Red Health Measures*.
- 2. Citizens and residents are free to travel abroad at any time provided that the Travel and Return Policy is adhered to when returning to Qatar.
- 3. The Ministry of Public Health advises citizens and residents to look up and comply with COVID-19 health measures currently in place in the destination country.
- 4. Travelers are responsible for keeping up to date with changes to the Travel and Return Policy through official sources before planning to travel to Qatar.
- Travelers must comply with Qatar's COVID-19 procedures at all time to reduce the spread of COVID-19.
- 6. Travelers who are required to have a PCR lab result before traveling to Qatar must have it at a medical center authorized by the health authorities in the country of departure. A negative test result is required and is **considered valid for 48 hours** from departure time at the country of departure. (Please see the pre-travel test rules for detailed guidance.)
- 7. Unvaccinated children **below the age of 12 years** travelling with fully vaccinated or recovered parent/s will follow the same rules that apply to their parent/s and are not required to have a pre-travel PCR test but only post-arrival test (Rapid Antigen Test) at the following locations:

a. Citizens and Residents: at any public/private clinic within 24 hours of arrival in Qatar but must sign an Undertaking form.

b. GCC Citizens (non-resident) and Visitors: if parent/s are exempted from quarantine, testing for children will be at the port of entry (airport, land, sea) upon arrival in Qatar; if parent/s are subject to hotel quarantine, testing will be at the quarantine hotel.

8. Non-residents of Qatar must register via the pre-travel registration system for people entering the State of Qatar on <u>www.ehteraz.gov.qa</u> website and upload all relevant official documents, where applicable, such as vaccination certificates, evidence of previous COVID-19 infection, serology antibody test results (for conditional vaccines), and PCR lab result at least 3 days before arrival. Although

uploading the PCR test result is not mandatory during the electronic pre-registration process, travelers who are required to have pre-travel PCR test, must present the original copy of the PCR test result to the airlines in order to allow them to board the plane, or at the country's ports (land and sea). Your pre-travel online registration will help accelerate your passage and clearance at the port of arrival for a better arrival experience in Qatar.

- 9. While pre-travel registration remains optional for citizens and residents of Qatar, the Ministry of Public Health recommends that all individuals entering Qatar pre-register to ensure the best experience upon arrival particularly those traveling with unvaccinated family members who are required to complete home quarantine as they are required to sign an Undertaking which is readily available in the Ehteraz online registration.
- 10. The Ministry of Public Health has the right to conduct random COVID-19 testing (Rapid Antigen Test or PCR) of travelers upon arrival in Qatar through its air, land and sea ports.
- 11. Travelers should download the Ehteraz mobile application and activate it on their mobile phones using a local or international SIM card.
- 12. All passengers must sign an Undertaking and **Acknowledgement Form** before arriving in Qatar. The form is available on the Ministry of Public Health website, pre-registration platform website www.ehteraz.gov.qaand airline online booking form. Citizens and residents are exempted from this requirement on the condition that they are fully vaccinated inside the State of Qatar arriving from one of the countries to which Standard Health Measure apply.
- 13. Self-testing of Rapid Antigen is not applicable to travelers. Post-travel/upon arrival Rapid Antigen Testing must be conducted at an authorized healthcare facility: (Please see our post-travel testing policy for detailed instructions) as follows:

a. Citizens and Residents: at any public (PHCC) or Private clinic.

b. GCC Citizens (non-resident) and Visitors: anyone subject to home quarantine with first-degree relatives shall have their testing done at any authorized private clinics; for unvaccinated children below 12 yrs old who are accompanied by parent/s exempted from quarantine, testing will be at the port of entry (airport, land, sea).

c. Travelers who are subject to hotel quarantine will have their testing done at the hotel.

- 14. Travelers who are required to complete quarantine in a hotel quarantine facility must book a Welcome-Home quarantine package through Discover Qatar's website https://www.discoverqatar.qa/welcome-home/.
- 15. In the case of home quarantine, accommodation conditions must be appropriate, and if the property does not comply with the conditions mentioned in the undertaking, the traveler must book the hotel quarantine package through Discover Qatar's website before travelling to Qatar.
- 16. Travelers arriving in Qatar should go to the COVID-19 test clinic at the entry port in case of any COVID-19-related symptoms and take the necessary isolation measures.
- 17. Travelers should not go to work or mix with others until the Rapid Antigen Test result is out.
- 18. For unvaccinated travelers, their health status in the Ehteraz app will be Yellow because they are under quarantine (please review the quarantine policy for detailed instructions).
- 19. Travelers should, on regular basis, check the MoPH Travel and Return Policy for up-to-date detailed guidance according to the country classification and health and safety measures.
- 20. Mekhaines quarantine period shall remain at 7 days.

Switzerland, Syria, Tajikistan, Thailand, Tunisia, Turkey, USA, United Arab Emirates, United Kingdom, Uzbekistan, Venezuela and Viet Nam if arriving on a direct flight from or transiting through any of the following countries: Albania, Andorra, Argentina, Armenia, Austria, Azerbaijan, Bahamas, Bahrain, Bangladesh, Belarus, Belgium, Brazil, Bulgaria, China (People's Rep.), Chinese Taipei, Colombia, Costa Rica, Croatia, Cuba, Cyprus, Czechia, Denmark, Djibouti, Dominican Rep., Egypt, Ethiopia, Finland, France, Germany, Greece, Hungary, Iceland, India, Iran, Iraq, Ireland (Rep.), Italy, Japan, Jordan, Kazakhstan, Kenya, Korea (Rep.), Kuwait, Kyrgyzstan, Lebanon, Liechtenstein, Luxembourg, Macao (SAR China), Maldives, Malta, Mauritius, Mexico, Moldova (Rep.),Mongolia, Morocco, Netherlands, New Zealand, North Macedonia (Rep.), Norway, Oman, Peru, Portugal, Qatar, Saudi Arabia, Serbia, Seychelles, Singapore, Slovakia, Slovenia, Spain, Sri Lanka, Sweden, Switzerland, Syria, Tajikistan, Thailand, Tunisia, Turkey, USA, United Arab Emirates, United Kingdom, Uzbekistan, Venezuela or Viet Nam; - students with a written approval issued by their university. The approval must have been submitted to the Federal Security Service of the Russian Fed. by the university;

- until 31 December 2023, passengers with an invitation letter issued by the Arctic Council Russia's Chairmanship Secretary;

4. Passengers entering or transiting the Russian Fed. must have a negative COVID-19 PCR test taken at most 2 days before arrival. The test result must be in English or Russian. A notarized translation to Russian is accepted. - This does not apply to:

- nationals of the Russian Fed.;

- passengers arriving from Armenia, Azerbaijan, Belarus, Kazakhstan, Moldova (Rep.), Kyrgyzstan, Tajikistan, Turkmenistan and Uzbekistan.

5. Passengers arriving from Armenia, Azerbaijan, Belarus, Kazakhstan, Moldova (Rep.), Kyrgyzstan, Tajikistan, Turkmenistan and Uzbekistan must have a negative COVID-19 PCR test taken at most 2 days before arrival. The test result must have a green QR code obtained in the app 'Traveling without COVID-19'.

- This does not apply to nationals of the Russian Fed.

6. Nationals of the Russian Fed. arriving from Botswana, China (People's Rep.), Eswatini, Hong Kong (SAR China), Kenya, Israel, Lesotho, Madagascar, Mozambique, Namibia, South Africa, Tanzania, United Kingdom or Zimbabwe are subject to a COVID-19 antigen test upon arrival.

7. Passengers arriving from China (People's Rep.), Israel or United Kingdom are subject to a COVID-19 antigen test upon arrival.

- This does not apply to nationals of the Russian Fed.

8. Flights from Morocco and Tanzania to the Russian Fed. are suspended.

10. Suspension of e-visa issuance.

SAUDI ARABIA - published 08.03.2022

1. Passengers are not allowed to enter.

- domestic workers of nationals of Bahrain, Kuwait, Oman, Qatar and United Arab Emirates. They must be

accompanied by the sponsor or one of the first degree family members of the sponsor;

Umrah passengers;

 passengers with a COVID-19 vaccination certificate showing that they received one vaccine dose in Saudi Arabia.

Passengers must register before departure at <u>https://mugeem.sa/#/vaccine-registration/home</u>.

- This does not apply to nationals of Saudi Arabia.

3. Passengers must have a COVID-19 vaccination certificate showing that they were:

- fully vaccinated with Janssen at least 14 days and at most 8 months before departure; or

- fully vaccinated with AstraZeneca (SK Bioscience), AstraZeneca (Vaxzevria), Covishield, Moderna (Spikevax) or Pfizer-BioNTech (Comirnaty) at most 8 months before departure; or

fully vaccinated with Sinopharm or Sinovac and received one dose of AstraZeneca (SK Bioscience), AstraZeneca
 (Vaxzevria), Covishield, Moderna (Spikevax) or Pfizer-BioNTech (Comirnaty) at least 14 days before departure;
 or

- fully vaccinated with AstraZeneca (SK Bioscience), AstraZeneca (Vaxzevria), Covishield, Janssen, Moderna (Spikevax) or Pfizer-BioNTech (Comirnaty), and received a booster dose.

They must register at <u>https://muqeem.sa/#/vaccine-registration/home</u> , and must download the Tawakkalna App and submit their personal details within 8 hours after arrival.

This does not apply to:

nationals of Saudi Arabia;

passengers younger than 18 years;

- first degree family members of nationals of Saudi Arabia;

- domestic workers of nationals of Saudi Arabia. They must be accompanied by the sponsor.

- 4. Passengers with a visit visa must have medical insurance to cover COVID-19 expenses.
- 5. Passengers could be subject to a COVID-19 PCR test upon arrival.
- 6. Suspension of visa on arrival facilities.
- 7. Suspension of e-visa issuance.

## Traveling to Sri Lanka

- Effective 1<sup>st</sup> March 2022, FULLY Vaccinated passengers do not require PCR or Antigen tests to entre Sri Lanka.
- Recommended doses of each Country varies, therefore, please follow below as appropriate to consider passengers as FULLY VACINATED and travel after 2 weeks of vaccination
- A traveler with 2 dose vaccine or a recommended combination, consider him/her as FULLY VACINATED
- A traveler with recommended one dose vaccine (eg; Janssen Vaccine) he/she is considered FULLY VACINATED
- Children 18 years and below, with recommended one dose is also considered as FULLY VACINATED and can travel after 2 weeks. Travel should be after 2 weeks after the vaccination and 7 days after .

# Travellers with past history of COVID-19 Infection

Infection detected between 7 days

before the date of departure and who has had at least a single dose is excepted and can travel, provided they should carry a diagnosis card or verifiable evidence of a Positive Covid-19 PCR report /Antigen report as proof of illness and in ENGLISH .travel after 7 days /after 2 weeks of vaccine.

Travelers with a history of Coivd-19 infection over 6 months

With one dose of vaccine, should travel after 2 weeks, and MUST CARRY A NEGATIVE PRE DPARTURE COVID-19 Test report taken within 72 hours or Rapid Antigen test within 48 hours and report must be in English.

- All other passengers 12 years and above who are NOT FULLY vaccinated must carry A Negative PCR test taken within 72hrs prior to their departure flight (OR
  - Rapid Antigen Test with negative results taken 48 hrs. prior to their departure flight.
  - On arrival ETA has been activated at BIA only for fully vaccinated Tourists.
  - Tourists may obtain Electronic Travel Authorization (ETA) using web protocol (<u>https://www.srilanka.travel/helloagain/</u>)
  - Airlines can carry any number of unvaccinated passengers per aircraft in to Sri Lanka.

- Details must be informed to area MOH on day 1 of arrival.

## **Airline Crew**

## **General Measures & Procedures (Mandatory to All Crew)**

- All Crew who have been vaccinated must carry Original Vaccination Certificate/Card in English. If the Certificate/Card is not in English, a certified English translation must be in possession;
- Crew Members if in Quarantine are to adhere to the public health measures of the Ministry of Health protocols in force at the time;
- Airlines to take measures to monitor and supervise the adherence of crew with regards to
- COVID19 preventive measures;
- Airline crew who has been in immediate close contact with a COVID19 patient shall not be enrolled for duty;
- Airline Crew must submit a completed Health Declaration Form upon Arrival to the Health Counters at the Airport.

## Foreign Airline Crew (Operating into Sri Lanka with a Foreign Carrier)

Foreign airline crew members shall adhere to the following guidelines in addition to General Measures.

- It is mandatory for the Foreign Airline Crew Members arriving into Sri Lanka to carry a Negative COVID-19 test result in English language done within 72 hours prior to departure.
- Airlines are permitted to select any hotel of their choice for crew that are fully vaccinated and 14 days have lapsed since the last dose.
- If crew layover for less than 72hrs, and the Unvaccinated Crew are confined to the Hotel Premises, the crew then do not require a PCR Test on arrival (Day 01)
- If layover is 72 hours or more in Sri Lanka, on arrival (Day One) PCR test shall be done and the Unvaccinated Crew Members shall be quarantined at the Hotel until they depart from Sri Lanka.
- After sample collection, for any operational reason the crew member can be released for a return flight without the result of the test

## Foreign Airline Crew who have been Fully Vaccinated (Final dose of Vaccine + 14 Days).

- It is mandatory for the foreign airline crew members arriving into Sri Lanka to carry a negative COVID-19 test result in English language done within 72 hours prior to departure;
- If the above-mentioned Test is Negative, they will be released without Day 01/ Arrival PCR Test and quarantine.
- If the Crew Member is staying for longer than 7 days, a PCR test is to be conducted on Day 07.

SWITZERLAND - published 18.02.2022

1. Passengers are not allowed to enter.

This does not apply to:

- nationals and residents of Liechtenstein and Switzerland;

- passengers with a "D" visa issued by Switzerland;

- nationals and residents of EEA Member States;

- passengers arriving from Schengen Member States;

passengers arriving from Andorra, Bahrain, Bulgaria, Chile, Chinese Taipei, Colombia, Croatia, Cyprus, Hong Kong (SAR China), Indonesia, Ireland (Rep.), Korea (Rep.), Kuwait, Macao (SAR China), Monaco, New Zealand, Peru, Qatar, Romania, Rwanda, San Marino, Saudi Arabia, United Arab Emirates, Uruguay or Vatican City (Holy See). If they transit through other countries, they must stay in the international transit area of the airport;
spouses, registered partners, children under 21 years, grandchildren under 21 years, dependent children, dependent parents or dependent grandparents of nationals of EEA Member States. They must present proof of their relationship;

- passengers with proof of being spouses, registered partners, children under 21 years, grandchildren under 21 years, dependent children, dependent grandchildren, dependent parents or dependent grandparents of "British Citizens", "British Overseas Territories Citizens" from Gibraltar or British nationals with a Certificate of Entitlement to the Right of Abode issued by the United Kingdom, who have a residence permit issued by Switzerland:

- with reference to the CH-UK agreement form 25 February 2019; or

- issued before 1 January 2021;

- unmarried partners of residents of Switzerland. They must have a written invitation from the residents in Switzerland and present proof of their relationship;

 passengers with a COVID-19 vaccination certificate showing that they were fully vaccinated at most 270 days before arrival. Vaccines accepted are AstraZeneca (Vaxzevria), Covaxin, Covishield, Janssen, Moderna (Spikevax), Novavx, Pfizer-BioNTech (Comirnaty), Sinopharm and Sinovac. More details can be found at <u>https://tinyurl.com/hyk4cbj7</u>;

- unvaccinated passengers younger than 18 years if they are traveling with their fully vaccinated parents/guardians;

- merchant seamen;

- military personnel with a letter issued by the Federal Department of Foreign Affairs of Switzerland or the Federal Department of Defense of Switzerland.

2. Passengers are not allowed to transit if arriving from a non-Schengen Member State to another Schengen Member State.

This does not apply to:

- nationals and residents of Liechtenstein and Switzerland;

- passengers with a "D" visa issued by Switzerland;

- nationals and residents of EEA Member States;

- passengers arriving from Schengen Member States;

passengers arriving from Andorra, Bahrain, Bulgaria, Chile, Chinese Taipei, Colombia, Croatia, Cyprus, Hong Kong (SAR China), Indonesia, Ireland (Rep.), Korea (Rep.), Kuwait, Macao (SAR China), Monaco, New Zealand, Peru, Qatar, Romania, Rwanda, San Marino, Saudi Arabia, United Arab Emirates, Uruguay or Vatican City (Holy See). If they transit through other countries, they must stay in the international transit area of the airport;
spouses, registered partners, children under 21 years, grandchildren under 21 years, dependent children, dependent parents or dependent grandparents of nationals of EEA Member States. They must present proof of their relationship;

- passengers with proof of being spouses, registered partners, children under 21 years, grandchildren under 21 years, dependent children, dependent grandchildren, dependent parents or dependent grandparents of "British Citizens", "British Overseas Territories Citizens" from Gibraltar or British nationals with a Certificate of Entitlement to the Right of Abode issued by the United Kingdom, who have a residence permit issued by

#### Switzerland:

- with reference to the CH-UK agreement form 25 February 2019; or

- issued before 1 January 2021;

- unmarried partners of residents of Switzerland. They must have a written invitation from the residents in Switzerland and present proof of their relationship;

 passengers with a COVID-19 vaccination certificate showing that they were fully vaccinated at most 270 days before arrival. Vaccines accepted are AstraZeneca (Vaxzevria), Covaxin, Covishield, Janssen, Moderna (Spikevax), Novavx, Pfizer-BioNTech (Comirnaty), Sinopharm and Sinovac. More details can be found at <u>https://tinyurl.com/hyk4cbj7</u>;

- unvaccinated passengers younger than 18 years if they are traveling with their fully vaccinated parents/guardians;

- merchant seamen;

- military personnel with a letter issued by the Federal Department of Foreign Affairs of Switzerland or the Federal Department of Defense of Switzerland.

## TANZANIA – published 27.12.2021 (Source CM/Tanzania)

1.All travelers including Tanzanians, returning residents and members of the crew1 /layovers are required to truthfully fill in an online Traveler's Health Surveillance Form available at <a href="https://afyamsafiri.moh.go.tz/">https://afyamsafiri.moh.go.tz/</a> for Tanzania mainland and <a href="https://healthtravelznz.mohz.go.tz">https://afyamsafiri.moh.go.tz/</a> for Tanzania mainland and <a href="https://healthtravelznz.mohz.go.tz">https://healthtravelznz.mohz.go.tz</a> for Zanzibar within 24 hours before arrival to URT`. 2.Filling of Traveler's Health Surveillance Form is a mandatory requirement before boarding to URT and there shall be a penalty to conveyances for noncompliance.

3. All travelers including Tanzanians and returning residents will be required to present a negative COVID 19 test certificate with QR code for verification upon arrival. The only accepted test is Real Time Reverse Transcription Polymerase Chain Reaction (RT-PCR) testing or Nucleic Acid Amplification Tests (NAATs) done at a nationally accredited/approved laboratory using sample tested within 96 hours before arrival to URT. Please note, negative COVID 19 test certificate upon arrival is mandatory, penalty shall be imposed to non-compliant conveyances while travelers without a negative COVID 19 test certificate upon arrival shall be denied entry and repatriated at conveyance cost.

4. All travelers, whether foreigners, Tanzanians or returning residents arriving from countries experiencing variants of concern/variants of interest, highest number of COVID 19 cases based on WHO epidemiological updates or those who have travelled through those countries in the last 14 days regardless of the routes taken shall be subjected to Rapid Antigen Tests at Points of Entry at their own cost. Cost for COVID 19 Rapid Antigen Test shall be 10 USD or TZS 23,000 of which is non-refundable and testing fees applies to travelers arriving in Tanzania Mainland by Air or Marine Vessels. For Zanzibar the cost for Rapid Antigen Test shall be 25 USD or equivalent to TZS. 58,000. Also, Travelers entering URT through Zanzibar having proof of fully vaccinated for COVID 19 using vaccine accepted by Revolutionary Government of Zanzibar will be exempted from Rapid Antigen Test. The updated list of countries for Rapid Antigen Test and accepted COVID 19 vaccines (Zanzibar) are available at 1 means persons on board a conveyance who are not passengers (source IHR, 2005 3rd Edition) <u>https://www.moh.go.tz</u> and <u>https://healthtravelznz.mohz.go.tz</u> website or at Points of Entry Foreign travelers and residents arrived through Zanzibar from COVID 19 high risk countries who wish to visit Tanzania mainland within 14 days from the date of arrival will be required to present a negative Rapid Antigen Test certificate obtained during entry, otherwise they will be subjected to Rapid Antigen Test at Points of Entry.

5. All asymptomatic travelers with positive Rapid Antigen Test at the Points of Entry shall be subjected to mandatory quarantine at their own cost at designated places under strict surveillance procedures until they test negative using RT PCR or otherwise evaluated by public health experts as non-infectious. The symptomatic positive Rapid Antigen travelers will be isolated for treatment at designated health facilities until they become asymptomatic and will be transferred to designated places for quarantine until tested negative using RT PCR. The list of quarantine places can be found at <u>www.moh.go.tz</u>

6. Travelers who were infected and recovered from COVID 19 shall be required to submit a proof of recovering from the disease obtained from Authorized Medical personnel upon arrival to Tanzania.

8. Children aged 5 years and below, Travelers in transit, Aircraft crew are exempted from both RT PCR certificate and COVID 19 Rapid Antigen Test.

9. All arriving conveyances must provide in advance passenger information so as to allow the Authorities at the Points of Entry to scrutinize the manifest for identification of possible high risk passengers and submit duly filled conveyance health declaration forms (Health Part of Aircraft General Declaration, Maritime Health Declaration and Ground Transport/Vehicles Health Declaration Form).

10. Arriving conveyances will be subjected to decontamination at Points of Entry where necessary.

11. All departing travelers are advised to seek information prior to departure from travel agent regarding COVID 19 requirements of their country of destination or conveyance to be used. However, the following requirement applies to specific destinations as follows;

a) Travelers to Dubai Airport or transit through Dubai Airport are required to possess a valid RT - PCR obtained within 48 hours from the time of collecting the sample and Rapid PCR (NAAT) performed with six (6) hours of departure.

b) Travelers to Republic of India, Republic of Rwanda, Democratic Republic of Congo and part of Europe are required in addition to a valid RT - PCR certificates specified by country of their destination to perform a COVID-19 Rapid Antigen Test prior to departure

- passengers transiting through Bangkok (BKK);

- passengers traveling to Bangkok (BKK), Phuket (HKT) or Ko Samui (USM).

2. Passengers must have a Thailand Pass QR code obtained at https://tp.consular.go.th

3. Passengers entering Thailand must have a negative COVID-19 RT-PCR test result issued at most 72 hours before departure from the first embarkation point. The test result must be in English or Thai;

- This does not apply to:

- nationals of Thailand traveling under the Alternative Quarantine (AQ) scheme;

- passengers younger than 6 years traveling with a parent/guardian;

- passengers with a positive COVID-19 RT-PCR test result issued at most 72 hours before departure from the first embarkation point, and a recovery certificate or proof of covid recovery for at least 14 days before travelling but less than 90 days from the first date of detection is required.

Passengers entering Thailand must have a COVID-19 vaccination certificate showing that they were fully vaccinated with AstraZeneca (Vaxzevria), Covaxin, Covishield, Janssen, Moderna (Spikevax), Pfizer-BioNTech (Comirnaty), Sinopharm, Sinovac or Sputnik V at least 14 days before departure. Flight number BKK-HKT is PG5275 and PG5279 only. b. Travelling with flight services between Bangkok and Samui for international transit/transfer passengers, Flight number BKK-USM is PG5125 and PG5171 only. 7. Passengers traveling under the Sandbox Program scheme must: - arrive at Bangkok (BKK), Phuket (HKT) or Ko Samui (USM); and - have a hotel reservation for 7 nights at AQ, or SHA Extra+ hotel, obtained at Amazing Thailand Safety and Health Administration (SHA) (thailandsha.com) or https://asq.in.th . 8. Passengers traveling under the Alternative Quarantine (AQ) scheme must have proof of payment for COVID-19 tests; and - a hotel reservation at AQ, OQ or AHQ hotel obtained at www.thailandsha.com and https://asq.in.th: - for 7 nights if they were fully vaccinated with AstraZeneca (Vaxzevria), Covaxin, Covishield, Janssen, Moderna (Spikevax), Pfizer-BioNTech (Comirnaty), Sinopharm, Sinovac or Sputnik V at least 14 days before departure; or - for 10 nights if they are not fully vaccinated. - Paid AQ hotel reservation confirmation (fully paid or at least 15,000 THB / 500 USD deposit) (including the fee for 2 RT-PCR tests for 7/10-day guarantine or 3 RT-PCR tests for 14-day guarantine) - Insurance with minimum coverage of USD 20,000 (not required for Thai nationals / foreign residents in Thailand can use social security or certificate from their employer) 9. Passengers transiting through Thailand must have: - a negative COVID-19 RT-PCR test result issued at most 72 hours before departure from the first embarkation point. The test result must be in English or Thai; or - a COVID-19 vaccination certificate showing that they were fully vaccinated with AstraZeneca (Vaxzevria), Covaxin, Covishield, Janssen, Moderna (Spikevax), Pfizer-BioNTech (Comirnaty), Sinopharm, Sinovac or Sputnik V at least 14 days before departure. - must have medical insurance with minimum coverage of USD 20,000 - This does not apply to: - passengers younger than 6 years traveling with a parent/guardian; - passengers younger than 12 years travelling with a fully vaccinated parent/guardian. 10. TURKEY - published 06.03.2022

1. Passengers must complete a "Traveler Entry" form at most 72 hours before departure. The form must be presented at check-in and upon arrival. The form can be obtained at <u>https://register.health.gov.tr</u>

2. Passengers arriving from Egypt or Iran must have:

- a negative COVID-19 PCR test taken at most 72 hours before arrival; or

- a negative COVID-19 antigen test taken at most 48 hours before arrival; or

- a negative COVID-19 PCR test taken at most 72 hours before arrival.

- This does not apply to:

- passengers younger than 12 years;

- passengers with a COVID-19 vaccination certificate showing that they were fully vaccinated at least 14 days before arrival;

- passengers with a COVID-19 recovery certificate. The passenger must have tested positive at least 28 days and at most 6 months before arrival;

- passengers arriving from Hungary or Serbia with a COVID-19 vaccination certificate issued by Hungary or Serbia, and their accompanying minors younger than 18 years;

- merchant seamen.

4. Passengers who in the past 14 days have been in Afghanistan, Bangladesh, Botswana, Brazil, India, Namibia, Nepal, Mozambique, Pakistan, South Africa, Sri Lanka or Zimbabwe must have a negative COVID-19 PCR test taken at most 72 hours before arrival.

- This does not apply to passengers younger than 12 years.

5. Passengers who in the past 14 days have been in Afghanistan, Bangladesh, Botswana, Brazil, India, Mozambique, Namibia, Nepal, Pakistan, South Africa, Sri Lanka or Zimbabwe must have a confirmed hotel reservation before departure. - This does not apply to:

- nationals and residents of Turkey;

- passengers with a COVID-19 vaccination certificate showing that they were fully vaccinated at least 14 days before arrival.

6. Passengers could be subject to self-isolation for up to 14 days.

- This does not apply to passengers with a COVID-19 vaccination certificate showing that they were fully vaccinated at least 14 days before arrival.

7. Diplomatic and official passports issued to nationals of North Macedonia (Rep.) which expired on 31 July 2020 or later are considered valid until 31 March 2022.

8. Airline crew members are exempted from PCR and quarantine requirements

- nationals of India with a visa issued by the USA or with a residence permit issued by USA, United Kingdom or an EU Member State traveling to Abu Dhabi (AUH);

- passengers traveling to Abu Dhabi (AUH) with a resident visa;

- passengers traveling to Abu Dhabi (AUH) with a pre-arranged visa issued by any emirate;

- nationals of Indonesia traveling under the Safe Travel Corridor program. They must have an entry permit and a return ticket.

- are subject to medical screening, and

- must download and register the COVID-19 DXB Smart App before departure or upon arrival.

Residents of United Arab Emirates with a residence visa returning to Dubai (DXB) or Al Maktoum (DWC) and arriving from Bangladesh, India, Nepal, Pakistan or Sri Lanka must have a GDRFA approval obtained before departure at <a href="https://smart.gdrfad.gov.ae/Smart\_OTCServicesPortal/ReturnPermitService.aspx">https://smart.gdrfad.gov.ae/Smart\_OTCServicesPortal/ReturnPermitService.aspx</a>.

- This does not apply to:

- first degree family members of nationals of United Arab Emirates and their accompanying domestic workers;

- nationals of Bahrain, Kuwait, Oman, Qatar and Saudi Arabia;

- passengers with a golden residence visa issued by United Arab Emirates.

The test certificate must be in Arabic or English and must be issued by a laboratory accredited by the departure country. The test certificate must also have a QR code.

The test certificate must be in Arabic or English and must be issued by a laboratory accredited by the departure country.

- This does not apply to:

- passengers younger than 16 years;

- passengers with a COVID-19 vaccination certificate with a QR code showing that they were fully vaccinated with AstraZeneca (Vaxzevria), AstraZeneca (SK Bioscience), Covaxin, Covishield, Covovax, Janssen, Moderna (Spikevax), Nuvaxovid (Novavax), Pfizer-BioNTech (Comirnaty), Sinopharm, Sinovac or Sputnik V;

passengers with a COVID-19 recovery certificate with a QR code issued at most 1 month before departure;
 passengers with disabilities.

7. Passengers entering Abu Dhabi (AUH), Fujairah (FJR), Ras Al Khaimah (RKT) or Sharjah (SHJ) from a country other than Afghanistan, Bangladesh, Botswana, Congo, Congo (Dem. The test certificate must be in Arabic or English and must be issued by a laboratory accredited by the departure country.

- This does not apply to:

- passengers younger than 16 years;

- passengers with a COVID-19 vaccination certificate with a QR code showing that they were fully vaccinated with AstraZeneca (Vaxzevria), AstraZeneca (SK Bioscience), Covaxin, Covishield, Covovax, Janssen, Moderna (Spikevax), Nuvaxovid (Novavax), Pfizer-BioNTech (Comirnaty), Sinopharm, Sinovac or Sputnik V;

passengers with a COVID-19 recovery certificate with a QR code issued at most 1 month before departure;
 passengers with disabilities.

8. A negative COVID-19 RT-PCR test result issued in United Arab Emirates presented upon departure from United Arab Emirates can be accepted for re-entry into Dubai (DXB) or Al Maktoum (DWC) if it meets the specific requirements based on the departure country.

- passengers with a letter of invitation or other official document, issued by the USA, by other government or by the United Nations, traveling on duty;

Rep.), Cote d'Ivoire, Djibouti, Egypt, Ethiopia, Gabon, Gambia, Ghana, Guinea, Guinea-Bissau, Haiti, Iraq, Kenya, Kiribati, Liberia, Libya, Madagascar, Malawi, Mali, Mozambique, Myanmar, Namibia, Nicaragua, Niger, Nigeria, Papua New Guinea, Senegal, Sierra Leone, Solomon Isl., Somalia, South Sudan, Syria, Tanzania, Togo, Uganda, Vanuatu, Yemen and Zambia, with a visa issued by the USA, excluding B -1 and B -2 visas;

- members of the U.S. Armed Forces, their spouses, and children younger than 18 years;

- merchant seamen with one of the following visas: C, D, C1/D, B1, H or L.

- passengers with a positive COVID-19 test taken at most 90 days before departure from the first embarkation point; and

- a letter issued by a health authority stating that the passenger has been cleared for travel;

- until 1 March 2022, nationals of USA and their family members arriving from Ukraine.
