# **Global Waiver for Schedule Changes**

#### Dear Trade Partners

Singapore Airlines (SIA) will be adjusting its Northern Summer 2023 schedules to improve overall network connectivity. Due to these changes, passengers may be impacted by schedule or aircraft changes. To enable our Trade Partners to self-service impacted tickets, SIA is issuing a global waiver policy as below.

#### 1. Eligibility Criteria (Must fulfil all conditions) for Rebooking

- a. Applicable for Singapore Airlines 618 tickets issued before/on 21 November 2022.
- b. Travel itinerary contains SIA-operated flights listed in the table below within the departure period (inclusive), where the sectors are affected by time/schedule change, flight cancellation or aircraft downgauge.

#### 2. What is waived for Rebooking

- **a.** Rebook the sector(s) affected up to 7 days before or after the existing date of travel at same RBD. If the same RBD is not available, book on the next lowest available RBD in the same cabin. Change fees and additional collection are waived.
- **b.** Re-routing is permitted with change fees waived. Fare differences (if any) <u>must be</u> collected.

#### 3. Eligibility Criteria (Must fulfil all conditions) for Refund

- a. Applicable for Singapore Airlines 618 tickets issued before/on 21 November 2022.
- b. Travel itinerary contains SIA-operated flights listed in the table below within the departure period (inclusive), where the sectors are affected by time/schedule change, flight cancellation or aircraft downgauge.

## 4. What is waived for Refund

**a.** Full refund (including ancillaries) will be accorded if the passenger does not wish to take up alternative options and no longer wishes to travel.

- a. For GDS bookings
  - For reissuance, insert the waiver code (provided below) into the endorsement box.
  - For refunds, insert the waiver code (provided below) into the remarks section.
- **b.** For NDC bookings, please contact your local Sales Ops / Sales teams to assist with the reissuance or refund.
