On DUB-PHL/BOS/SEA/MSP/YYZ

1. Reroute on a same day direct AA or B6 flight or connecting to a partner flight via a US gateway to/from Aer Lingus to travel on the original booked dates.
2. Change their booking to the nearest alternative date on a direct Aer Lingus service.
 - o No change fee will be charged.
 - o Any fare difference will be waived.
3. Apply for a refund.

On ORK-FAO

Customers will be automatically re-accommodated onto a same day Dublin service or an adjacent day Cork service, they will also have the following options.

1. Change their booking to an alternative date on a direct Aer Lingus service.
 - No change fee will be charged.
 - Any fare difference will be waived.
2. Apply for a refund.

On all other flights

Service is planned to continue on these routes and will be automatically re-accommodated to a same day Aer Lingus or Aer Lingus Regional flight.

These flights will be cancelled in Astral by 1700 on 27th March
